USGA RULES GOVERN PLAY

(Except for Local Rules)

- White stakes mark Out of Bounds on holes 3, 5, 10, 12, & 13. Road marks Out of Bounds on hole 11.
- Replace divots, repair ball marks, rake bunkers.
- Must have own bag and play 1 ball only.
- Shirts and proper attire to be worn at all times.
- Pace of Play is 2:05 for 9 holes and 4:15 for 18 holes.
 - * 1st Warning – Improve Pace of Play
 - * 2nd Warning – Group escorted to appropriate hole
 - * 3rd Warning – Issued rain check for remainder of holes to be played
- Golf carts must remain on cart paths on par 3s and around all tees and greens.
- Restrooms are located on holes 6, 11, & 14.
- ABC Law prohibits the consumption and possession of any alcohol not purchased from the facility, no exceptions.
- In the event of lightning, a warning siren will sound and all golfers must return to the pro shop.
